

□ Select "Sign Up" on the home page of "HKeToll" mobile app





■ Select "Typical Owner"






☐ If tunnel tolls of the commercial vehicle (e.g. taxi, minibus, bus, goods vehicle) will be paid by driver(s), please sign up for a "Commercial Vehicle Company" account

- Read the Terms and Conditions and the Personal Information Collection Statement. Confirm that you have read all the information, and click on "Next"
- ☐ Enter the Verification Code, then click on "Confirm"








Step 4:


☐ Enter account information. Then, click on "Next"

■ Enter at least one e-Contact (an email address or a Hong Kong mobile phone number) for receiving payment notification and other account information





Step 6:


☐ Check the information. Then, click on "Next"






Step 7.1:

- ☐ After receiving the message, enter the One-time Password








Step 7.2 :


Upon successful verification, "Verified" will be displayed on the screen. Then, click on "Next"



- Select "Add Vehicle" to associate a new vehicle





Step 2:


☐ On "My Vehicles" page, click on "Add Vehicle" to associate a new vehicle





Step 3:

Enter the Vehicle Registration Mark and the e-Contact of the Registered Vehicle
 Owner as registered in the Transport Department, and click on "Add"



☐ A vehicle to be added must have been associated with a vehicle tag or applied for a vehicle tag



Step 4:

- ☐ A notification of "Confirmation of the Vehicle Association" will be sent to the e-Contact of the Registered Vehicle Owner when this page is shown on screen
- ☐ The status of vehicle association to the HKeToll account will be in progress, until the Registered Vehicle Owner accepted the vehicle association





Step 5.1:

- □ The Registered Vehicle Owner will receive a notification of "Confirmation of the Vehicle Association" through the e-Contact as registered in the Transport Department
- □ Please click on the link in the notification. You will be redirected to a web page.







- Enter the One-time Password






